EXCLUSIVE AGENCY CONTRACT

IT IS AGREED AS FOLLOWS:

- 1. Engagement: Talent hereby engages Agent to be his or her sole and exclusive personal manager, agent, representative and business advisor to supervise, guide and direct all business arrangements for Talent's services in the fields of television, radio, internet and any other electronic, computer or digital related media, known or unknown ("Broadcast Field") in the following fields: newscasting, news anchoring, reporting, weathercasting, sportscasting, producing and/or hosting. Agent accepts such engagement on the terms set forth below,
- 2. Duties of the Agent: During the Term of this Agreement:
 - (a) Agent shall advise, counsel and guide Talent with respect to: (i) the proper development of skills and talent; (ii) the type of position Talent should seek: (iii) the market in which, and the particular station in such market at which, Talent should be employed; (iv) the appropriate compensation for Talent's services, and; (v) other provisions of Talent's Employment Contract.
 - (b) Agent shall act as the exclusive negotiator for Talent in the Broadcast Field.
 - (c) Upon request, Agent shall advise, counsel and guide Talent with respect to: (i) content, sequence and selection of material of all audition tapes used to promote and market Talent's work; (ii) vocal delivery, reporting and anchoring techniques, and other on-camera skills; (iii) clothing and make-up; (iv) preparation for job interviews; (v) resolution of disputes with Talent's Employer; (vi) solicitation and acceptance of new assignments and duties from Employer; (vii) acceptance of freelance assignments, when permitted by Talent's Employer.
 - (d) Agent shall bear all ordinary expenses in connection with the performance of its duties hereunder, including telephone, fax, photocopying, postage, tape dubbing and editing, and messenger expenses.
 - (e) Agent shall inform Talent of all verbal or written requests for Talent's services in the Broadcast Field.
 - (f) Agent may render similar services to others, including persons of the same general qualifications as Talent, who may be eligible for the same employment.
- 3. <u>Place of Performance of Agent's Duties:</u> Agent may perform all its duties from its offices in New York. Agent shall not be required to travel or meet with Talent or Talent's Employer or prospective employer at any particular place, except in Agent's discretion.
- 4. Term: This Agreement shall commence on the date it is signed by Agent and shall continue for a period of two (2) years or the length of any Employment Contract entered into by Talent, whichever is longer ("Initial Term"). Thereafter this Agreement shall be renewed for periods of two (2) years ("Renewal Term") from the end of the Initial Term and of any Renewal Term unless either party advises the other, in writing, at least thirty (30) days prior to the end of the Initial Term or the end of any Renewal Term, that said party elects to terminate this Agreement. The "Term" of this Agreement shall mean the Initial Term and all Renewal Terms.
- 5. Representation and Covenants of Talent:
 - (a) Talent warrants and represents that he or she is free to enter into this Agreement and does not now have, and during the term of this Agreement will not have, any contract or obligation which will conflict with the terms and provisions of this Agreement.
