

WRITING SERVICES AGREEMENT



WHEREAS, the rewrite ("Re-write") of the screenplay for the Picture (the "Screenplay") to be written by Writer hereunder will be based on an original screenplay created by Jeff Ingber entitled "Return to Felicity", and furnished by Company (the "Underlying Work");

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the parties agree as follows:

CONDITIONS: Company's obligations hereunder shall be conditioned upon and subject to the Company's receipt of this Agreement, and Exhibit A, attached hereto, executed by Writer.

2. SERVICES/CONSIDERATION:

Fixed Compensation: Writing services shall be deemed commenced upon Company's receipt of this Agreement signed by Writer. Compensation shall be as set forth below, but shall in any event not be less than the minimum amounts payable for a "Low Budget" theatrical motion picture re-write pursuant to the terms of the Writer Guild of America ("WGA") Minimum Basic Agreement ("MBA"), the terms of which are hereby incorporated by reference. The fixed compensation amounts shall be payable as follows: one-half shall be payable upon commencement, and the remainder shall be payable upon delivery of the applicable Form of Work.

- Writer's services shall be non-exclusive but on a "no material Services/Exclusivity: interference" basis during all Writing Periods and Reading Periods, unless postponed or suspended pursuant to the terms hereof. Writer shall render all services customarily rendered by writers in the motion picture industry and at all times promptly comply with Company's instructions. Writer expressly acknowledges that, as a material term of this Agreement. Writer shall incorporate in each Form of Work all such notes, suggestions and instructions of which Writer may be advised by Company.
- Work: As used herein the "Work" shall mean all results and proceeds of Writer's services hereunder, including, but not limited to, all protectable ideas, pitches, notes, and comments of Writer with respect to the Screenplay and the Picture and including each Form of Work set forth in Section 2(a) above.
- Schedule of Services: Time is of the essence with respect to Writer's writing services, which, for clarification, shall be performed and delivered in accordance with the following:
- Commencement of Services: Writer shall commence writing the Rewrite upon Company's receipt of this Agreement signed by Writer. Company shall thereafter have the option to request that Writer commence subsequent writing steps, provided that such writing steps are commenced (subject to
